I. Call to Order & Introductions

 Battenberg moved to waive all past fines (approximately \$1100) in the process of going fine free. Lewandowski seconded. Motion pass unanimously.
- E. Carpeting Informational Mountford has been gathering information and preliminary estimates.
- F. Safety procedures for start of school year (Covid-19) Action
 Henning moved to give Mountford full authority to make Covid safety decisions. Battenberg seconded. (Battenberg, Henning, Krueger, and Vosters in favor, Lewandowski, Biermeier opposed).

Lewandowski made a motion to not approve a masking policy because it is redundant under the terms of the previously passed Covid policy (see Unfinished Business F). Krueger seconded. Motion passed unanimously.
