Any qualified elector who is unable or unwilling to appear at the polling place on Election Day may submit a request to vote an absentee ballot to their municipal clerk. A qualified elector is any U.S. citizen, who will be 18 years of age or older on Election Day, who has resided in the ward or municipality where he or she wishes to vote for at least 28 consecutive days before the election. The elector must also be registered in order to receive an absentee ballot. Proof of identification must be provided before an absentee ballot may be issued.

You must make a request for an absentee ballot in writing or online at MyVote.wi.gov.

Contact your municipal clerk and request that an application for an absentee ballot be sent to you for the primary or election or both. You may also submit a written request in the form of a letter or you may apply for an absentee online at MyVote.wi.gov. Your written request must list your voting address within the municipality where you wish to vote, the address where the absentee ballot should be sent, if different, and your signature. You may make application to your municipal clerk for an absentee ballot in person, by mail, by fax, by email or at MyVote.wi.gov.

Making application to receive an absentee ballot by mail

The deadline for making application to receive an absentee ballot by mail is: 5 pm on the fifth day before the election, THURSDAY, OCTOBER 29, 2020

Note: Special absentee voting application provisions apply to electors who are indefinitely confined to home or a care facility, in the military, hospitalized, or serving as a sequestered juror. If this applies to you, contact the municipal clerk regarding deadlines for requesting and submitting an absentee ballot.





Whereas, the City of Waterloo seeks to attract new businesses and employment opportunities, and;

Whereas, 575 West Madison Street is up for auction on October 28, 2020 with bidders currently conducting due diligence property research, and;

Whereas, as it has done in the Treyburn Farms residential development projects, the City has an opportunity to incentivize and encourage real estate brokers to successfully bring clients to our community for the benefit of Waterloo's greater good.

Therefore, Be It Resolved, by the Common Council of the City of Waterloo, Wisconsin, that it hereby authorizes the Mayor and Clerk/Treasurer to enter into a co-brokerage agreement with Investment Advisory and/or its associates (the auction house) for the purpose of generating quality bidders as follows:

- Offer a municipal 1.5% co-brokerage incentive, with the auction house also offering a 1% incentive.
- Funded using Tax Incremental Finance #2 fund balance.

After discussing with our team, comments are below:


- 1. Excited to see the city considering to offer up 1.5% fee
- 2. The below proposed payout is too complicated in comparison to our standard process. Since we are asking a lot of our Buyers, we keep things simple (communication/documentation/expectations/etc)
- 3. Since it is an auction, we cannot list pricing or have a contingency on pricing.
- 4. We would be willing to market a 1% finder's fee from our side, if the City of Waterloo is willing to offer 1.5% finder's fee with no contingencies.

Josh,

Below criteria I put out to a receptive Mayor about municipal co-brokerage sweetener. How soon could we know RE: highlighted?

- Similar to what we did with Treyburn with a sweetener to an agent bringing a buyer to the table, I propose the City authorize an expenditure of 1.5% of the sale price (cap at \$15,000) as a co-broker incentive to the winning bidder only if all the following conditions are met:
 - The auction house agrees on or before October 8th to also puts in 1%, meaning the co-broker commission would be roughly 2.5% -- enough to get brokers who otherwise don't have a reason to lift a finger to go to work for their clients.

- The winning bid is greater than \$1,075,000 or greater. [This amount gets us out from underneath a loan guarantee call].
- The winning bidder certifies that the facility will serve as the primary work place for a minimum of 15 employees within nine months of closing.
- The winning bidder is not among those I've already route to the auction house: Trek, EVCO Plastics or Rock Auto
